Its been a steady year at the regsitrar's desk with 42 horses registered this year (only 26 last year) and 38 (18 last year) changes of ownership.

That's a good solid amount of rego's and its also great to see the number of changes of ownership steadily increasing. I think having the registered owner listed on the website database has certainly helped this.

This was the second year of registering using our new categories and I think this is continuing to work well.

I have just been approached by another purebred colt owner about inspecting her three year old, so the future is looking bright.

I am still loving the Registrar's job. I am still managing to turn around registrations usually the same day the completed Microchip Form comes back to me and do batch runs on loading them onto the website database.
